

## RULES FOR THE BLOODY GREAT CAR LOTTERY 2026

### Bloody Great Car Lottery – Terms and Conditions

1. **Promoter**

The promoter of the Bloody Great Car Lottery is **Foundation for A Bloody Great Cause Ltd** (ABN 81632588713).

2. **Purpose of the Lottery**

The lottery is conducted to raise funds for the charitable work of the Foundation for A Bloody Great Cause Ltd, supporting awareness, research and clinical trials for blood cancers and other blood disorders.

3. **Permit**

This lottery is conducted in accordance with the requirements of **NSW Fair Trading** and the **Community Gaming Act 2018 (NSW)** and associated regulations.

Permit number: **[GOCAU/2679]**.

4. **Eligibility**

- Entry is open to persons **18 years of age or older**.
- Tickets must not be purchased by, or on behalf of, a person under 18 years of age.
- Management and committee members of the foundation may purchase tickets unless otherwise restricted by regulation.

5. **Ticket Price**

Tickets are **\$20 each, 3 for \$50 or 6 for \$100**

6. **Ticket Sales**

Tickets will be available for purchase via:

- **Online sales**, and
- **Authorised printed tickets sold by representatives of the Foundation for A Bloody Great Cause Ltd.**

Each ticket purchased represents **one entry into the draw**.

7. **Lottery Period**

Ticket sales will commence on the 23<sup>rd</sup> March and will close **prior to the draw on 23 October 2026**, or earlier if all tickets are sold.

8. **Prize**

The prize will be the **Bloody Great Car Lottery vehicle prize** as advertised by the foundation.

The prize is **not transferable or redeemable for cash**

9. **Draw Details**

The draw will take place at **The Bloody Great Night Out** on **23 October 2026** at: Doltone House Hyde Park

The winning ticket will be selected **via an electronic random draw system**.

10. **Winner Announcement and Notification**

- The winner will be announced at the event.
- The winner will be notified by **telephone and/or email** using the contact details provided when purchasing the ticket.
- Results may also be published through the Foundation's website and social media channels.

#### 11. **Claiming the Prize**

The winner must provide **valid identification** and proof of ticket purchase if requested in order to claim the prize.

#### 12. **Unclaimed Prize and Redraw**

If the prize remains **unclaimed after three months**, a redraw may be conducted in accordance with the requirements of **NSW Fair Trading**.

The redraw details, if required, will be announced by the Foundation through its communication channels.

#### 13. **Liability**

To the extent permitted by law, the Foundation is not responsible for:

- Any lost, late, incomplete or misdirected entries.
- Any technical issues affecting online ticket sales.
- Any damage, loss or injury suffered in connection with the prize, except where liability cannot be excluded by law.
- The promoter will keep records of ticket sales, the draw process and prize allocation for the period required under NSW legislation.

#### 14. **Privacy**

Personal information collected from ticket purchasers will be used solely for the purposes of:

- administering the lottery,
- contacting the winner, and
- communicating with supporters of the Foundation for A Bloody Great Cause Ltd.

Personal information will be handled in accordance with applicable **privacy laws** and will not be shared with third parties except where required by law.

#### 15. **Acceptance of Terms**

By purchasing a ticket, participants agree to be bound by these **Terms and Conditions**

#### 16. **Dispute Resolution**

Any disputes or complaints concerning the conduct of the lottery will be referred in writing to the promoter, **Foundation for A Bloody Great Cause Ltd**, within a reasonable period following the draw.

The promoter will review the matter and take reasonable steps to resolve the dispute in accordance with the **Community Gaming Act 2018 (NSW)** and associated regulations.

If the dispute cannot be resolved by the promoter, the matter may be referred to **NSW Fair Trading** for guidance or further investigation.
